

**NOTICE TO ALL DOG OWNERS**  
**Rabies Vaccinations and Dog Licenses are Required**

Please be reminded that pursuant to Sec. 174.05(1) Wis. Stats., notice is hereby given to all owners of dogs in the **Town of Fremont, Waupaca County** that rabies vaccinations and dog licenses are required by Thursday, March 31, 2022, or the owner will incur a late charge as of Friday, April 1, 2022.

Wis. Stats. 95.21(2) requires that dogs be vaccinated for rabies by a veterinarian at no later than 5 months of age and revaccinated within one year after the initial vaccination and every 3 years thereafter. We do not keep paper copies of rabies information on file, proof of current immunization against rabies must be presented at the time the license is requested. If you cannot find your dog's rabies shot certificate, please contact your veterinarian for a duplicate copy.

**License Fee Schedule:**

Neutered or Spayed Dog = \$ 3.00

Un-Neutered or Un-Spayed Dog = \$ 8.00

Kennel License = \$35.00 for 12 dogs, \$3.00 for each additional dog over 12

*Any applications received after March 31<sup>st</sup> will be assessed an extra \$5.00 per dog.*

Please complete the application below for a dog license if we currently **do not** have your dog information on file or you are applying for the first time. This application is for a dog license valid for one year, from January 1, 2022 to December 31, 2022 to keep one dog described as follows in the Town of Fremont. A separate application is required for each dog.

Include with the application:

- 1) Certificate of Rabies Vaccination
- 2) Proof of Spaying or Neutering
- 3) Self-addressed envelope (for return of your documents and license)
- 4) Check made payable to the Town of Fremont
